Terms of use the public Wi-Fi service in Mie prefecture

Article 1 Objective

These Terms of Use (hereinafter referred to as the "Terms") set forth the necessary matters to try to improve the convenience for getting information using public Wi-Fi service (hereinafter referred to as the "Service") which is provided Mie prefecture (hereinafter referred to as the "Mie") and Kankohanbai systems Inc. (hereinafter referred to as the "Systems") for users who are foreign tourists to Mie as well as residents.

Article 2 Type of service

The service is provided the area with a better public Wi-Fi connection to the user who agreed to the terms and user can access to the internet.

Article 3 Terms of conditions

This Service could be used by the user personally who agreed to the terms.

Article 4 Use of service

User set up the necessary terminal device and software (hereinafter referred to as the "terminal device") for using this service. It is free to use.

Article 5 Retention of use

- 1. Utility time, user access history to sites etc., terminal device identity and setup information is recorded for operations management, understanding of the usage situation and improvement of convenience for users,
- Mie and Systems shall not be open to the public the recorded information under paragraph
 (1) in the form of determinable the personal terminal device except as governed in law etc.

Article 6 Prohibited matter

1. The user shall be prohibited from engaging in any of the following activities except as governed in law etc.

(1)To perform any act or interests which would infringe of the privacy rights, other rights, the other third parties

(2)In addition to paragraph (1), to perform any act or interests which would be detrimental to other parties or Mie.

(3)To act, defamation of other third parties.

(4)To perform any act against public order and good morals.

(5)To perform any act for property benefits of gangsters which is governed by violence law prescribed in paragraph 2 of Article 2.

(6)In addition to paragraph (5), to perform any act which is likely to interfere with the operation of the Service.

- 2. In cases of the Systems determines that the user falls under any of the items of above, Mie and the Systems may prohibit the use of the Service without prior notice to the user.
- 3. In cases of that there was damage to Mie and Systems, user or other parties who committed the act which falls under the item 2, user assume full legal responsibility even if the service

Is already used and Mie and Systems shall not be responsible or liable.

Article 7 Suspend operation

1. In the event of any of the following circumstances, Mie and Systems reserves the right to permanently discontinue the use of the Service without prior notice to the user.

(1)When Mie and Systems conducts scheduled or unscheduled inspections or maintenance of the computer systems relating to the Service.

(2)When the operation of the Service becomes unavailable due to riot, destabilization, labor dispute, earthquake, explosion, flood, tsunami, fire, power outage and any other emergency.

(3)When the Service failures occur in the related systems

(4)When for any other reason Mie and Systems determines that such discontinuation or suspension is necessary.

2. Mie and Systems shall not be responsible or liable for any damages incurred to the users or other parties by the suspension of operation

Article 8 Disclaimer

- 1. Mie and Systems makes no warranty, completeness, accuracy, certainty, availability regarding the type of service and some information which the user get through this service.
- 2. In no event shall Mie and Systems be responsible or liable for provision, delaying, change, discontinuation or abolition, registration through the Service, loss of any information of user which is provided or through the use, damage with computer virus etc. by the user, data corruption, electronic eavesdropping, unavailability of use this service caused by wave condition, suspension or any other damage incurred by the user in connection with Service.
- 3. The users are required to pay all expenses through the use of the usage fees with or without cause.
- 4. The users set up the equipment to connect to the service and in no event shall Mie and Systems be any responsible even if it is unavailable incurred by the terminal device or software etc.
- 5. In cases where disputes arise between the user and another user or between the user and a third party in connection with the use of this service, in no event shall Mie and Systems be any responsible.
