The program is designed to support the continuation of business and can be widely used for business in general.

X1 Restaurants

Good: Cafeterias, restaurants, taverns, coffee shops, etc.

N/A: Excluded are restaurants with outdoor space only, take-out stores, kitchen cars, food stalls, etc.

N/A: Supermarkets and convenience stores with an eat-in space are not eligible.

***2** Restaurant business partners

Good: Food suppliers, hand towel suppliers, and other businesses that have a direct and continuous business relationship with restaurants in Mie Prefecture.

Payment amount

Restaurants 300,000 yen <u>per restaurant</u>

Restaurant business partners 300,000 yen per company

Taxi operators and driving agents 300,000 yen per company

3 Main requirements for payment

Please be sure to check the guidelines before applying.

- (1) The applicant must have a store, etc. in Mie Prefecture and have been operating a business since before November 30, 2020.
- (2) The applicant must have obtained the necessary permits, etc. to operate each business on or before November 30, 2020.
- (3) Sales in any month of December 2009, January 2010, or February 2021 must have decreased by 50% or more compared to the same month of the previous year.

5 Documents required for application

- Please read the application guidelines on the Mie Prefecture website carefully and prepare the necessary documents before submitting your application.
- The following documents are required for application, in addition to the application form, written pledge, etc., as specified in the application guidelines.

(1) Copy of business license, etc.(When necessary for business)	Copies of permits, certifications, etc., necessary for conducting the project to be supplied.
(2) Sales ledger, etc.	The month of the decrease in sales (December 2010, January 2011, or February 2021) and the same month of the previous year
3) Copy of tax return	Receipt stamp required. If the application is submitted via e-Tax, the receipt notice must be submitted.
(4) Documents that verify your identity	A copy of your driver's license or other photo ID
(5) Copy of bankbook	The front side of the bankbook and the first and second pages that show the account number and account holder.
(6) (Restaurants only) Photographs of interior and exterior view of the store	Photographs taken in or after March 2021 (We may also ask for photographs of restaurant transaction business, taxi operators, and driving agents)
(7) (Business partners only) Documents confirming direct dealings with restaurants	Documents confirming direct transactions with the restaurant (e.g., delivery receipts, receipts, etc.)
