

Mie Prefecture Shortened Hours Request Cooperation Money (April 26, 2021 - May 11, 2021)

Ver.2

In order to prevent the spread of the new coronavirus infection, we will provide cooperation money to restaurants in Mie prefecture that can cooperate with our request to shorten their business hours to 20:00.

Request period

From **Monday, April 26, 2021 to Tuesday, May 11, 2021**

If you start shortened business hours before or on Wednesday, April 28, you will be eligible for the payment.

Main requirements for payment

- The restaurant must be located within Mie prefecture (whether or not alcoholic beverages are served is not a question).
- Full cooperation for the entire period of the shortened hours request (eligible for payment if the shortened hours start before or on April 28) at all restaurants.
*Full cooperation means that the company will cooperate with the shortened hours request for the entire period of the shortened hours request (if the shortened hours start before or on April 28 as the preparation period for the restaurants, the company will be eligible for the payment, but the amount of the payment will be calculated according to the period of implementation), and that all restaurants will cooperate with the shortened hours request by not operating from 20:00 to 5:00 in the next morning (asking customers to leave).
- A valid permit under the Food Sanitation Law must have been obtained prior to April 25, 2021, and must be valid for the entire period of the shortened hours request.
- Normal business hours must have been over 20:00 prior to April 25, 2021.
- Adherence to industry-specific guidelines and infection prevention measures.

<Specific Examples of Non-included Restaurants etc> *For details, please refer to the Q&A on Mie Prefecture website.

- Restaurants specializing in home delivery, take-out, supermarkets and convenience stores with an eat-in space, kitchen cars, etc. are NOT included.
- NOT included when food and drink are served only to hotel guests at banquet halls of hotels.

*If any facts or falsehoods that do not meet the requirements are discovered after the granting of the cooperation money, the full amount will be required to be returned.

Per restaurant per day

- Small and medium-sized companies: JPY 25K to 75K depending on the amount of sales
- Large companies: 40% of the amount of decrease in sales (up to JPY 200K*)

*Whichever is lower, JPY 200K or the daily sales of the last fiscal year or the fiscal year before last x 0.3

Outline of the application process

(1) Please check the contents of the request and the requirements for payment.

(2) Conduct business in response to requests for shortened hours
(stop business operation after 20:00)

Please take photos of the restaurant to prove the shortened hours (**post a notice announcing the shortened hours**) and photos of the exterior and interior of the restaurant.

After publication of application guidelines

Please wait for the application guidelines as they are being prepared. (It is to be posted on Mie prefecture website in mid-May.)

The latest information will be updated on Mie Prefecture website, so please check.

Please read the application guidelines carefully and prepare the necessary documents before submitting your application.

(3) Preparation of necessary documents

In addition to the application (form), written pledge (form), etc., please prepare documents that objectively show the actual status of the business (copy of business license, copy of tax return, etc.) as attachments.

(4) Confirmation of necessary documents based on the check sheet

Please use the checklist to make sure that all necessary documents are in order

(5) Application (by mail)

*If the documents are incomplete or if the actual business status cannot be objectively confirmed from the submitted documents, the cooperation money may not be provided.

Application period and documents required for application
